- 5. Sealed or electronic bids must be submitted to the office Office of **Jeetpursimara Sub-Metropolitan City**, **Jeetpur, Bara** by hand/courier or through PPMO website www.bolpatra.gov.np/egp. on or before the deadline. Bids received after this deadline will be rejected.
- 6. The bidswill be opened in the presence of Bidders' representatives who choose to attend at the Office of **Jeetpursimara Sub-MetropolitanJeetpur Bara.** Bids must be valid for a period of 90 after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of ebid,, which shall be valid for **30 days** beyond the validity period of the bid. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited infollowing account and submit the receipt of the deposited amount of cash along with the bid:-
