 - (c) Value Added Tax registration certificate and Permanent Account Number (PAN) registration certificate,
 - (d) Tax clearance certificate **FY2076/2077** or the document of having submitted tax returns of the period specified by the Public Entity obtained from the Inland Revenue Office,
 - (e) A written declaration made by the bidder with a statement that he/she is not ineligible to participate in the procurement proceedings; has no conflict of interest in the proposed 32 procurement proceedings, and has not been punished for a profession or business related offense.
 - (f) For the bidder's within the municipality should be registered in the Municipality.

Bids must be valid for validity period after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in following account and submit the receipt of the deposited amount of cash along with the bid
